Registration

A registration fee of NZ Dollars (NZD) 200 and Internship placement fee of NZD 150 is payable when you enrol for any course at Crown. This is a once-only payment. If you extend or change your course you do not pay another registration fee.

Accommodation

There is a once-only payment of NZD 200 (accommodation reservation fee) for arrangement of your accommodation. The weekly accommodation fee varies according to the type of accommodation you reserve. If you choose homestay or HomestayPLUS, any unused portion of this fee is refunded if you find other accommodation. There are no refunds if you move out of a studio or apartment early. We must receive two weeks' notice of your intention to leave your homestay. If you go on holiday and wish to return to the same homestay, there will be a NZD 140 (homestay) or NZD 210 (HomestayPLUS) per week fee. This is paid to the homestay to reserve your place.

Payment of fees

Attendance and behaviour

You will be expected to attend classes punctually and to behave in a responsible manner at Crown. If your attendance does not meet Crown's requirements or if your behaviour is detrimental to the school, school staff, counsellors, homestays, studio and apartment operators, contractors, or to other students, you may be asked to leave the school. In this event, your tuition and resource fees will not be refunded.

Fee protection, cancellations and refunds

Pursuant to NZ government student fee protection requirements, the full value of your outstanding fees is protected in an approved trust fund. Trustee: HMT Group. Please note the following conditions:

1. Courses of three months or more

If the course is of three months duration or more and the withdrawal occurs up to the end of the tenth working day after the first day on which Crown requires you to attend the classes, you will be entitled to receive a full refund less a deduction for costs incurred by Crown, up to a maximum of 25% of fees paid (if entering NZ on a Crown visa) or up to 10% of tuition fees for the cancelled weeks (if not entering NZ on a Crown visa).

If your visa is declined before entering New Zealand and you have paid all tuition fees, your fees will be refunded in full, less NZD 200.

(As per section 235A (1) (a) and (b) of the Education Act and as set out in the Education (Refund Requirements for International Students) Notice 2012.

2. Courses of five weeks or more but less than three months

If the course is of five weeks or more but less than three months and the withdrawal occurs up to the end of the fifth day after the start of the course, you will be entitled to receive a full refund less a deduction for costs incurred by Crown, up to a maximum of 25%.

3. Courses shorter than 5 weeks

If your course is shorter than 5 weeks, you may withdraw up until the end of the second day and receive a refund of at least 50% of any amount paid. However, if two days constitutes the full amount of tuition paid for by the student, the PTE may retain 100 per cent of the payment

4. If you cancel all or part of your course after the refund period, you will not be entitled to a refund and Crown may retain 100% of tuition fees for the cancelled weeks.

5. The refund period ends at 5:00 pm on the tenth working day of your course. If you cancel your course within the refund period, you must return in good condition any textbooks you have received.

6. Cancellation of your course in the event of financial problems at Crown: The full value of your outstanding tuition fees is protected in an audited trust fund. In the unlikely event that Crown could not deliver your course, you would receive a full refund of all outstanding fees, or have these transferred to one of our partner institutions to enable you to complete your course.

7. All withdrawals, cancellations and course change requests must be received by Crown in writing. Cancellation and course change forms are available from Student Services, Crown Institute, 3rd floor, 80 Anzac Avenue, Auckland (english@crow.ac.nz).

8. If your fee was received by Crown from a Crown retailer then any refund will be made to that Crown retailer. Unused homestay fees may be refunded directly to you.

9. If you pay by Credit Card (either directly or through a Crown retailer) and cancel your course, the refund amount will have the merchant fee deduction included.

Transfers, liability and insurance

You may transfer fees between departments and courses at Crown, but your fees may not be transferred to another person. Crown will not be liable for any loss, damage or injury incurred within the school, with a homestay family or on a school excursion. In starting a course of study at Crown, you will be deemed to have accepted all of our Enrolment Conditions. You must have appropriate and current medical and travel insurance while in New Zealand and Crown can provide information on policies on request. Crown will not be liable if, for any reason, the published courses cannot be offered. Crown reserves the right to change courses and fees without prior notice.

QUESTIONS and ANSWERS

1) What are the conditions for enrolling on Study and Internship?

You must be at least 18 years at the date of starting the course. You must have a minimum of Lower Intermediate English ability. This is equivalent to Crown Level 4+, or IELTS 4.0+ or TOEIC 400+.

2) How do I enrol in Study and Internship?

You can enrol through your local education retailer or agent. If you do not have a retailer or agent, please email us at sandi@crow.ac.nz. You can write to us in your own language if you like.

3) I am not sure of my English language level. What can I do?

Your local education retailer or agent can arrange a simple Crown test. This takes about 30 minutes. We may interview you to check your speaking and listening ability. We can do this by phone or Skype.

4) Do I need a visa to take part in Study and Internship?

No, you can take this course with a visitor visa up to 12 weeks. You can also take this course if you have a Working Holiday visa or a Work visa.

5) What sort of intern job will I be able to get? Who will I intern for, and will I get a Certificate?

Your job will depend on your skills, experience and English language ability, and job availability in Auckland. Your job could be in customer service, administration and support and will involve interaction with New Zealand people.

Crown is a leading vocational college, so our students have worked and interned for many international and NZ companies, including: Air NZ, Qantas, Function Staff, Fonterra, Our Pacific Tours, Ramada Hotel and other leading hotels, Toyota NZ, STA Travel, Singapore Airlines, Avis Rent-A-Cars, Just Water, Fullers Auckland and many others.

6) What if I do not like my intern placement? Can I try another company?

If the internship placement is not successful for reasons beyond your control, we may place you with another company. This will be at Crown's sole discretion. There is no additional fee for this service.

7) Can I take an additional English language course before I start Study and Internship?

Yes, you can take one or more weeks of special English for Work Purposes to prepare for Study and Internship. The cost of additional full time English tuition is NZD 330 per week.

8) What Study and Internship packages are available?

9) I want to combine different classes and take a customized package. Can I do this?

Yes, please let us know which classes you want to take. General English, Activities and Kiwi Class start any Monday and are in blocks of one week. Other classes are in two week blocks and include the following topics: Flight Attendant, Airline Reservation Systems, Barista, and Hotel Reception and Concierge.

10) What is the cost of Study and Internship?

2019 fees: The enrolment fee is NZD 350 (course registration fee NZD 200 and Internship placement fee NZD 150), paid once only, non-refundable. The weekly tuition fee is NZD 450 per week (3 week & 4 week packages). 5+ weeks on request. Please email us at sandi@crow.ac.nz.

Accommodation placement is NZD 200, paid once only. Homestay is NZD 290 per week. Airport transfers are NZD 110 each way. You must have travel and health insurance. You can arrange this yourself, or we can arrange it for you.
